he 7th edition of *The Green Book* from Forward Analytics provides, for all 72 counties, the most recent information on a variety of organizational, demographic, financial, and economic measures. The data is the most recent available, typically from 2022 or 2023. The book displays the data for all counties, which is useful for quick comparisons between counties.

This county insert presents all of your county's data in an easy-to-use form. Here you will find information on three measures of your county board and administration, seven measures of population and demography, eight measures of county finances, and 10 measures of your county's economy, development, and infrastructure, including two new housing measures.

Each table also provides, for each measure, your county's rank among Wisconsin's 72 counties. A rank of one

always indicates the lowest value while a rank of 72 indicates the highest value, regardless of whether a low value is considered better or worse than a high value. The third column in each table shows the state average for each measure. For the median values, consult *The Green Book*.

The value of each measure is from latest data available as of July 1, 2024. The applicable year is listed with each measure. To provide comparable numbers for counties with varying populations, many measures are converted to per capita figures.

BOARD & ADMINISTRATION

Counties vary in the type of administration and the size of their county boards. The maximum board size is set in state law and depends on county population. Population per district measures the size of each district in constituent terms.

Six indicators of economic health, a net commuting measure, and three measures of development and infrastructure are shown below. Ranks are low values (1) to high values (72). For some measures, a low rank is good, while for others a high rank is preferred.
